

Privacy Policy

Collection of your Personal Information

MGTC may collect personally identifiable information. MGTC may also collect anonymous demographic information, which is not unique to you. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by MGTC. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the MGTC website.

MGTC may share data with trusted partners to help perform statistical analysis, send you email or postal

mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to MGTC, and they are required to maintain the confidentiality of your information.

MGTC may keep track of the websites and pages our users visit within MGTC, in order to determine what MGTC services are the most popular. This data is used to deliver customized content and advertising within MGTC to customers whose behavior indicates that they are interested in a particular subject area.

MGTC will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on MGTC or the site; (b) protect and defend the rights or property of MGTC; and, (c) act under exigent circumstances to protect the personal safety of users of MGTC, or the public.
